#### First aid measures

- First-aid measures after inhalation : Remove person to fresh air and keep comfortable for breathing.

### 5. Fire fighting measures

- Suitable extinguishing media : Use proper extinguishing media depending on peripheral fire, Water spray, Foam, Carbon dioxide, Dry powder, Sand.
- Unsuitable extinguishing media : Do not use a heavy water stream.
- Hazardous decomposition products in case of fire : In case of fire, product may produce irritative or toxic fumes/gases.
