## 4. First aid measures

### First aid measures

- First-aid measures after inhalation : Remove person to fresh air and keep comfortable for breathing.

## 5. Fire fighting measures

- Suitable extinguishing media : Water spray

## 6. Accidental release measures

### Personal Precautions, Protective Equipment and Emergency Procedures

- General measures : Before entering, ventilate the area.  
Do not let unauthorized persons come close to the area.  
Immediately place the leakage area in isolation, with taking proper distances for all directions.  
Wear appropriate personal protective devices to prevent inhalation and contact with eye, skin, and clothing, and never attempt to work on the lee.

### Environmental precautions

### Methods and Equipment for Containment and Cleaning up

- Methods for cleaning up : Clean up any spills as soon as possible, using an absorbent material to collect it.

Wash out the spilled area with large amounts of water.  
If possible, neutralize with slaked lime, soda ash, etc. before washing out.
